- Exit 169 at 71st St and go west about ½ mile to Mingo Rd. Turn North (right) to the UMAC, about ¼ mile, just past the last Sam's Club entrance.

Pool Info

- Results will be posted hourly online at www.redskinvolleyball.net. **INFORM YOUR PARENTS.**
- 7:30 Coaches' Meeting at the north table in the arena. Captains will be called 20 minutes prior to play.
- Pool A is best 2 out of 3 sets, cap at 27, and set three will be to 15 with no cap.
- Pool B is three sets to 25, cap at 27.
- Warm-ups will be 4-4-2 for the first match and 3-3-1 for later matches.
- Teams will provide players to keep book, flip score, track libero, and line judge.
- During pool play, have your team ready to officiate at the conclusion of the previous match—we need to keep matches moving.

Tie Breaker Process

- Consider 1st—Head to Head Matches (Pool B only)
- Consider 2nd— Overall set percentage won during pool play (Sets Won/Total # of Sets Played)
- Consider 3rd— Overall point differential
- Consider 4th—Coin Toss
- If it is a three way tie, the above process will determine the winner of the pool (tie for 1st) or bye (tie for 2nd), and the remaining teams will play one game to 15 with no cap.

Bracket Play—The top two teams in each pool will advance to the gold division, and the bottom two will advance to the silver. Matches play in the same format as pool play but with no cap. Gold will play on Court 1 and silver will play on Court 2.

Gold Bracket

CT1-M1—1st Pool A vs 2nd Pool B (Ref—2nd Pool A)
CT1-M2—2nd Pool A vs 1st Pool B (Ref—Loser M1-CT1)
CT1-M3—Winner M1 vs Winner M2 (Ref—Loser M2-CT1)

Silver Bracket

CT2-M1—4th Pool B vs 3rd Pool A (Ref—3rd Pool B)
CT2-M2—3rd Pool B vs Winner M1 (Ref—Loser CT2-M1)
